WITHOUT

LIMITATION:

1. Drowning while engaged in boating, fishing and wading
2. Injuries received from mechanical and moving boat parts
3. Injuries received from fishing equipment
4. Injuries received from others, including my guide, using fishing equipment
5. Injuries received from encounters with wildlife and/or insects
6. Injuries received from exposure to the sun, lightning, wind, weather, and elements
7. The absence of rapid medical attention/emergency response

I understand the risks, hazards, and dangers of fishing and have had the opportunity to discuss them with a representative of Lagos JetSki Limited (Lagos Fishing Charters). I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. I AM VOLUNTARILY USING THE SERVICES OF Lagos JetSki Limited (Lagos Fishing Charters) WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, DISABILITY, OR DEATH.
